In Canada, bankruptcy and insolvency is within federal jurisdiction, and the Superintendent of Bankruptcy supervises the administration of all estates to which the Bankruptcy Act applies. Regional or district offices of the Superintendent of Bankruptcy are maintained in various localities. Each office maintains an alphabetical index of the names of all bankrupts within its locality. The indices include the courts of jurisdiction and the names of the trustees appointed to administer the bankrupt estates. When the locality of the bankrupt is known, the regional or district office in that locality may be contacted at the address listed. If the locality of the bankrupt is not known, the Head Office of the Superintendent of Bankruptcy may be asked for direction to the appropriate regional or district office.
